1. INTENT

This policy governs the requirements for admission into all courses at Edith Cowan University (ECU) and the pathways through which eligibility for course entry can be demonstrated.

2. ORGANISATIONAL SCOPE

This policy applies to all ECU staff involved in the processes governed by this policy.

3. DEFINITIONS

ATAR	Australian Tertiary Admission Rank
Entry pathway	The pathway through which an applicant gains entry to the University
Mature-age	Mature entry (for applicants who will be 20 years of age or over in the year they are intending to commence studies)
Minimum English Standard	The minimum English standard required for entry to an ECU course
Portfolio Entry	Entry based on an assessment of a portfolio of evidence, showing an ability to succeed in higher

	education. This entry pathway may also require an interview
Notional ATAR	An ATAR derived based on an entry pathway or prior study
STAT	Special Tertiary Admissions Test

4. POLICY CONTENT

4.1 ECU's awards align with the requirements of the following Commonwealth Government instruments:

- a. The [Higher Education Standards Framework \(Threshold Standards\) 2015](#); and
- b. The [Australian Qualifications Framework \(AQF\)](#).

4.2 This policy is aligned to the [AQF Qualifications Pathways Policy](#) and the granting of advanced standing; recognition of prior learning; and credit transfer will be carried out in compliance with that policy.

4.3 Attachment 1 contains the detailed entry pathways and admission requirements for each type of course offered at ECU, including AQF Levels 1 to 10 and ECU's non-AQF courses.

4.4 All applicants for entry into ECU courses will be assessed in a transparent and equitable manner.

4.5 Courses delivered by other institutions are assessed for entry into ECU courses in accordance with the [Advanced Standing Policy](#).

4.6 In cases of educational disadvantage the Academic Registrar may admit a student by giving consideration to the applicant's relative disadvantage and previous performance in other relevant studies.

4.7 In appropriate disciplines in Performing Arts, students will normally be required to meet the ECU minimum entry requirements. Students with outstanding performing arts capability may be admitted to the course with the approval of the Deputy Vice-Chancellor (Academic), without satisfying these requirements, if there is demonstrated evidence of outstanding performance capability in the discipline for which entry is sought.

4.6 The admission requirements are reviewed on an annual basis by the Academic Registrar. Minor amendments proposed by the Academic Registrar must be

endorsed by the Deputy Vice-Chancellor (Academic) and forwarded to the Academic Board for noting.

- 4.7 When a course-specific minimum ATAR is amended, the Notional ATAR for other entry pathways must also be reviewed.

5. ACCOUNTABILITIES AND RESPONSIBILITIES

In relation to this policy:

- a. The Deputy Vice-Chancellor (Academic) has overall responsibility for the content of this policy and its operation; and
- b. Academic Registrar is responsible for the proper application of the requirements set down in this policy.
